**ORDER:**

Government have formulated the "Andhra Pradesh Community Based Tank Management Project" (APCBTMP) with Government of India and World Bank assistance. About 3000 minor irrigation tanks, expecting to cover about 2.5 lakh Ha ayacut, are proposed to be restored under the project with an estimated cost of Rs 1044.30 Crores (World Bank Loan of Rs 835.40 Crores (equivalent to 63 Million SDRs (IBRD Credit) + US\$ 94.5 Million (IDA Loan)) and Government of India Grant of Rs 208.90 Crores). The entire tank restoration work would be undertaken in three batches over a period of 5 years.

2. The objective of the project is to improve tank system based livelihoods and strengthen community management of selected tank systems. The four components of the project are;

**Component-I:** Strengthening community based institutions to assume responsibility for tank system improvement and management: This component is primarily for capacity building, exposure visits and training of WUA members and engineers etc.

**Component-II:** Tank systems improvements & Ground water interventions in selected tanks: This component covers all civil works related to restoration of tanks (catchment area, tank and command area). Subject to the financial limits set by the Government, a WUA could implement some of the works such as repairs to feeder channels, jungle clearance, revetments and distribution channels, if they so desire and have the requisite capacity.

**Component-III:** Agriculture Productivity Enhancement for tank system users: The component involves activities like agriculture and other farm related demonstrations, market linkages, WUA's capacity building, professional services, organizing Farmer Field Schools and exposure visits etc.

**Component IV: Project Management:** This component involves project Management activities like cost of hired staff, consultants, professional Services, studies, research, work shops, seminars and other office expenditure and Support facilities

3. Government have issued orders vide G.O.Ms.No.231, I & CAD (PW-EA) Department, dated 23.12.2006 for Implementation and fund flow arrangements for all the above 4 components of Andhra Pradesh Community Based Tank Management Project (APCBTMP).
4. Component wise cost of the project is indicated in Annexure.
5. The Expenditure is chargeable to the Head of Account " 2702 - Minor irrigation - 01 Surface Irrigation - MH 101 Water Tanks - GH 03 Externally Aided Projects - SH (06) WUA programme under APCBTMP - SH (07) Tanks System Improvements under APCBTMP - SH (08) Agriculture Production Enhancement Programme under APCBTMP - SH (09) Administration under APCBTMP"
6. Government after careful consideration, hereby accord administrative approval to the "Andhra Pradesh Community Based Tank Management Project" for an estimated amount of Rs 1044.30 Crores. (Rs One thousand forty four crores and thirty lakhs only)
7. The Project is implemented with World Bank Loan and Government of India Grant, as indicated in Annexure.
8. The legal agreements for the Project have been signed on 08-06-2007
9. The Project Coordinator (Commissioner CAD & Principal Secretary, I&CAD Dept.) shall approve the annual action plan for the Project and the State Project Director shall take necessary action for implementation of the Project in terms of G.O.Ms. No. 231, I&CAD (PW-EA) Department, dated 23-12-2006.
10. Procurement Procedures prescribed by World Bank should be followed for procurement of Works, Goods and Consultancies.
11. The Project Coordinator (Commissioner CAD & Principal Secretary, I&CAD Dept.) shall obtain financial sanction for Annual Action Plan of each year separately.
12. This order issues with the concurrence of Finance (PMU) Dept. vide their U.O.No. 486/Fin.PMU/06, dated : 06-07-2007
